08. Pre-qualification criteria:

- (a) The contractor should be have experience of executing Installation of split air conditioner of any make and should have completed at least two works of similar nature of work.
- (b) Contractor should have a service Centre at Delhi NCR.
- (c) Bidder must enclose EMD amount of Rs 7000/- in the form of demand draft, without which his bid will be not be considered.

The contractor should also furnish documentary evidence, complete details of the concerned authority such as name with designation, valid address, telephone/ mobile number with STD Code, where similar job have been executed.

(b) No subletting or sub-contracting of the supply will be permitted without the expressed consent of RCB authorities.

The envelops should be super-scribed clearly with Name of work and NIQ No, providing name(s) and postal address of the supplier with Phone/ Mobile/ Fax numbers and e-mail address if any.

The offer shall remain open for at least 60 days. Earnest Money Deposit (EMD) amounting to Rs.7,000/- shall be accepted only in the form of Demand Draft drawn in favour of the Executive Director, RCB, payable at Faridabad and submitted along with the bid. EMD exemption is not allowed in any circumstances.

GENERAL TERMS AND CONDITIONS

Work: Installation Testing & Commissioning of 02 Nos x 5.5 TR Ceiling suspended split A/c (Retrieved- Pre-used) at ATPC Reception

- 01. The work shall be executed as per schedule of work, specification tender's terms and conditions, CPWD specification and instruction of Engineer-in-charge.
- The rates shall be inclusive of all taxes, duties and cartage.
- Quantities are indicative and the bidder is to inspect the site for estimating quantities as per site requirement. RCB reserves the right to issue orders under the contract, the cumulative value of which may vary from the estimated quantity/cost. Supplier will have no objection for variation in quantities thereon. Payment will be as per actuals.
- 05. The Executive Director, RCB reserves the right to cancel any or all the tenders without assigning any reason.
- 06. Duly sealed quotation shall be dropped in the tender box placed at the reception counter of the RCB building
- 07. **No escalation** in any form either of materials or of labour shall be payable by the Centre.
- 08. All materials brought at site shall be got approved by the Engineer-in-charge before being used. Test certificates of material should be provided by contractor, if required by Engineer-in-charge.
- 09. No T & P shall be supplied by the Institute.
- 10. No advance payment shall be made.
- 11. Security deposit of 5% of each bill will be deducted and same will be released after successful expiry of defect liability of one year from date of completion of each supply.
- 13. Time allowed for the supply shall be strictly followed otherwise the supplier shall be liable to pay compensation at the rate of 0.5% of the contract value of the job undone per week of delay on the part of the contractor subject to a maximum of 5% of the total contract value.

However, for any reason beyond the control of the supplier, the extension of time shall be granted upon application by the contractor in prescribed format. No claim for any compensation during the extended period shall be entertained and the centre's decision in this regard shall be final.

- 14. For proper completion of the supply, if any quantity variation or extra items are required, the supplier shall execute the same. Rates of extra items shall be derived from the tender itself as far as possible or else prevailing market rates shall be adopted.
- 15. In case the supplier resiles from the offer within the validity of tender or contractor fails to commence the work after issue of the award letter, the earnest money will be forfeited. On commencement of the contract, the amount of earnest money will be released after successful completion of the first supply under the contract.
- 16. Any claim dispute or difference arising out of or in connection with this agreement and which cannot be settled by mutual consultations, shall be referred to sole Arbitration or an Arbitrator to be appointed by mutual consultations. The award of the Arbitrator shall be final and binding between the parties to this agreement. The Arbitrator proceeding shall be governed by the Arbitration and conciliation ordinance dated 26th March, 1996 and shall be conducted in Delhi.

The agreement drawn shall be subjected to the jurisdiction of the courts at Delhi.
