Sub Disposal of the condemned official vehicle bearing Regn. No. DL 12C 2924 (LMV - MARUTI SX4) - Reg.

Regional Centre for Biotechnology is proposing to dispose off its condemned official vehicle bearing Registration No. DL 12C 2924 (LMV - MARUTI SX4) on **"AS IS WHERE IS BASIS"**.

2. Accordingly, sealed quotations are invited for the disposal of the said vehicle on the terms and conditions mention below. Persons/firms, interesting in purchasing the above mentioned vehicle, may submit their highest quotations in the enclosed Proforma in a sealed cover addressed to the undersigned latest by 14.00 Hrs. on or before 10.04.2019 at RCB. The bidders or their representatives, not more than one for each bid, may be present, if they so desire, at the time of opening of Quotations. The cover should be prominently superscripted with the words **"QUOTATION FOR PURCHASE OF CONDEMNED VEHICLE"** and addressed to the Registrar, Regional Centre for Biotechnology, NCR Biotech Science Cluster, 3rd Milestone, Faridabad-Gurgaon Expressway, Faridabad - 121 001

3. The said vehicle will be available for inspection between 3.00 PM to 4.30 PM on any working day from 01.04.2019 to 05.04.2019 in presence of the authorized official designated for this purpose. The prospective bidders may visit RCB under prior intimation to the undersigned.

4. The Auction of the said vehicle will be governed by the following conditions:-

i. The said vehicle will be auctioned separately not through any lot.

ii. The vehicle will be sold on "As is where is basis". The auction process will be conducted in presence of Disposal of Goods Committee.

iii. The bidders are required to pay Earnest Money of Rs.10,000/- (Rupees Ten thousand only)

iv. Earnest Money is payable by means of Demand Draft/Banker's Cheque drawn in favour of "the Executive Director, Regional Centre of Biotechnology", payable at Faridabad. CASH/CHEQUE SHALL NOT BE ACCEPTED for this purpose.

v. Quotations received without Earnest Money Deposit will not be considered and shall be summarily rejected.

vi. The successful bidder will be required to deposit the bid amount by means of Demand Draft drawn in favour of "The Executive Director, Regional Centre of Biotechnology", payable at Faridabad, within two working days of the acceptance of bid.

vii. The Earnest Money of the successful bidder will be released only after the deposit of the bid amount. Earnest Money will not be adjusted as bid amount and will be forfeited, if he fails to honour the bid. In case of failure to deposit final bidding amount, the respective vehicle may once again taken up for re-auction.

viii. The delivery of the auctioned vehicle will be arranged only after the successful bidder submits documentary evidence in support of residential status (PAN Card, Aadhar Card etc. in case of individual and Registration Certificate etc. in case of firms).

ix. The auctioned vehicle will be removed by the successful bidder within 02 working days of depositing the bid amount, at their own expenses.

x. The vehicle will be disposed off on "as is where is basis" and no guarantee for its worthiness or quality will be given by this Institute.

xi. This Institute will not owe any responsibility for transfer of vehicle and for any other liability for using these vehicle for commercial or any other purpose after sale.

xii. The successful bidder will also be responsible for getting Registration Certificate of the vehicle and/or any other documents as required by the RTO, in his name at his own cost expeditiously. This Office will not be responsible for any lapse on his part in this regard.

xiii. If, the successful bidder wants to scrap the vehicle, then he should have to submit the cut part of the chassis number to this office immediately.

xiv. The bidder will not be allowed to withdraw their bids and if they do so their earnest money will be forfeited.

xv. The Bid amount is excluding GST, as the GST is to be paid by the recipient of the goods as per the rates applicable.

xvi. The Executive Director, RCB, reserves the right to accept or reject any/all of the quotations without assigning any reason.

xviii. Staff on regular rolls of the Regional Centre for Biotechnology are not eligible to participate in the bidding.
