NOTICE INVITING QUOTATION

Sealed quotations are invited from Electrical items supplier/contractors on behalf of the Executive Director, Regional Centre for Biotechnology for the supply of PVC Raceway, as per schedule and General terms & conditions available at www.rcb.res.in, eprocurement.gov.in Regional Centre for Biotechnology Faridabad.

- 01. Name of supply:** Supply of PVC Raceway 100 X 50 mm at Regional Centre for Biotechnology Faridabad, NCR Biotech Science Cluster 3rd Milestone Faridabad- Gurgaon Expressway Faridabad.
- 02. Estimated cost :** Rs 1.77 Lac

- 08. Pre-qualification criteria:**
- (a) The supplier should be Reputed Electrical contractor/Supplier and must have supplied electrical items or executed electrical work in Govt/ PSU/Autonomous bodies or Reputed private sector.
 - (b) Supplier should have its firm/ and or office in Delhi-NCR.
 - (c) EMD of Rs 3500/- in the form of Demand Draft from Nationalized/scheduled bank drawn in favour of Executive Director Regional Centre for Biotechnology, Payable at Faridabad.

The envelopes should be super-scribed clearly with Name of work and NIQ No, providing name(s) and postal address of the supplier with Phone/ Mobile/ Fax numbers and e-mail address if any.

The offer shall remain open for at least 60 days. Earnest Money Deposit (EMD) amounting to Rs.3500/- shall be accepted only in the form of Demand Draft drawn in favour of the Executive Director, Regional Centre for Biotechnology, payable at Faridabad must be enclosed failing which, bid will summarily rejected.

GENERAL TERMS AND CONDITIONS

Name of Supply: Supply of PVC Raceway 100 X 50 mm at Regional Centre for Biotechnology Faridabad, NCR Biotech Science Cluster 3rd Milestone Faridabad- Gurgaon Expressway Faridabad.

01. The supply shall be done as per schedule of items, specification terms and conditions and instruction of Engineer-in-charge on as and when required basis.
02. The rates shall be inclusive of cartage/ loading unloading or any other expenses. GST should be clearly shown separately. Rate must be valid and firm for a period of six month from the date of award of contract/Letter.
03. Quantities are indicative and likely to increase. Supplier will have no objection for variation in quantities thereon. Payment will be as per actual supply executed.
04. The lowest bidder will be awarded order for supply of item.
05. The Executive Director, RCB reserves the right to cancel any or all the tenders without assigning any reason.
06. Duly sealed quotation shall be dropped in the tender box placed at the reception counter of the RCB building
07. No escalation in any form either of materials or of labour shall be payable by the Centre.
08. All materials brought at site shall be got approved by the Engineer-in-charge before being used
09. No T & P shall be supplied by the Institute.
10. No advance payment shall be made.
11. Security **deposit of 5%** of bill amount will be deducted and same will be released after successful expiry of defect liability of six from date of completion of supply. EMD amount of success bidder will be adjusted against Security Deposit.
12. EMD of unsuccessful bidders will be returned after finalization of tender.

13. Time allowed for the supply shall be strictly followed otherwise the supplier shall be liable to pay compensation at the rate of 0.5% of the contract value of the job undone per week of delay on the part of the contractor subject to a maximum of 5% of the total contract value.

However, for any reason beyond the control of the supplier, the extension of time shall be granted upon application by the contractor in prescribed format. No claim for any compensation during the extended period shall be entertained and the centre's decision in this regard shall be final.

14. For proper completion of the supply, if any quantity variation or extra items are required, the supplier shall execute the same. Rates of extra items shall be derived from the tender itself as far as possible or else prevailing market rates shall be adopted.

15. In case the supplier resiles from the offer within the validity of tender or contractor fails to supply items as per specification after issue of the award letter, the earnest money will be forfeited. Other suitable administrative punitive action may also imposed as deemed fit.

16. Any claim dispute or difference arising out of or in connection with this agreement and which cannot be settled by mutual consultations, shall be referred to sole Arbitration or an Arbitrator to be appointed by mutual consultations. The award of the Arbitrator shall be final and binding between the parties to this agreement. The Arbitrator proceeding shall be governed by the Arbitration and conciliation ordinance dated 26th March, 1996 and shall be conducted in Delhi.

The agreement drawn shall be subjected to the jurisdiction of the courts at Delhi.
